If approved for funding by the FMFCD Board of Directors, FMFCD agrees to fund a field trip for the School/Organization to Scout Island. Funding includes payment of the Scout Island docent fees and transportation costs. Scout Island fees will be paid directly to the Fresno County Office of Education or Organization by FMFCD.
